"Church & Dwight Co., Inc. is voluntarily recalling all lots within expiry of Zicam® Cold Remedy Nasal Swabs, Zicam® Nasal AllClear Swabs, and Orajel™ Baby Teething Swabs to the consumer level. The products are being recalled due to potential microbial contamination identified as fungi in cotton swab components."

## **Heat-Related Illness Among US Patients Experiencing Homelessness**

"Climate change is increasing the frequency, duration, and severity of heat waves,<sup>1</sup> and consequently the risk of heat-related illness. Several factors—including increased exposure, multimorbidity,<sup>2</sup> and involuntary displacement (eg, from shaded parks, with loss of essential items)<sup>3</sup>—are associated with higher risk of heat-related illness among people experiencing homelessness (PEH), especially unsheltered individuals."
